CREATION OF TRUST:

01. That, in order to effectuate his aforesaid desire, the settlor set apart and handed over to the trustees a sum of Rs 100000/- (One lac only.) (here in after called the "Trust Fund" on 19th day of June 2020. which expression shall include cash and any other assets or investments of any kind whatsoever into which the same or any part there of might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the Trust subject to the powers, provisions, agreements and declarations herein after contained here to in this deed.

02. The name of trust shall be:

“ S.S. FOUNDATION ”

03. **PLACE OF OFFICE :**

The principal place of office of the Trust is presently situated At- Dostpur, Post-Bariyarpur, Dist-Sitamarhi, (Bihar) Pin Code-843302. The trust may however open its office/sub-offices/branches at places as may be considered necessary by the board of trustees from time-to-time.

04. **OBJECTS:**

A. That the MAIN OBJECTS for which this trust is established are:

- (I) To establish manage and run “ S.S.FOUNDATION ” Trust At- Dostpur, Post-Bariyarpur, Dist-Sitamarhi (Bihar) Pin Code-843302.
- (II) To establish, run, support, develop, and maintain schools, colleges, libraries, reading rooms, universities, laboratories, research institutions and other institutions of the like nature in India, for use of students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general and to establish and run nursing homes, maternity homes, old age care centre and other specialized health service providing centre.

- (III) To establish maintain and run studentships, scholarships and render other kind of aid to students including supply of books stipends, medals and other incentives to study without any distinction as to cast, color, race, creed or sex.
- (IV) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefits of the public in general.
- (V) To establish, maintain or grant aid for the establishment and maintenance of parks, gardens, gymnasiums, sports, clubs, ponds, lakes and rivers for all round development of human resources and use by public in general.
- (VI) To establish maintain or grant aid to homes for the aged, orphanages or other establishment for the relief of widows and aged persons and to educate them for better life and prosperity.
- (VII) To establish and develop institutions for the physically handicapped and disabled or mentally retired persons and to provide them education, food, clothing or other help.
- (VIII) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire and epidemic diseases etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work for the purpose of development and inculcation of social activity among the people.
- (IX) To make the country pollution free special emphasizes on more and more plantations, specially the plants and herbs of medicinal value.
- (X) To establish maintain or grand aid to homes and the institutions working in the eradication of child labour, specially working in Hazardous factories, all over India .
- (XI) To establish and develop institutions for eradication of Early marriage specially among S.C., S.T., O.B.C., and minorities, Also the welfare of widows, specially the widows of our brave soldiers who lost their lives in service of Nation .
- (XII) To establish and develop institutions for e-learning and e-training and digitalization in different sectors as needed time to time.
- (XIII) To grant aid or render assistance to other public educational trusts or institutions.

B. INCIDENTAL AND ANCILLARY OBJECT:

In furtherance of the above objects and other objects hereinafter contained in this deed the trustee may do the following acts deeds and things:

(i) To apply the ~~whole or part of the income~~ or whole or part of the corpus of trust fund for one or more of the object of the trust. Provided that not with standing anything here in before or herein after contained, the income as also corpus of this Trust funds shall be applied and/or applicable only to or for such public charitable purposes and objects as define under the provisions of income tax act, 1961 and within such territories only and subjects to such conditions or limitations, if any, may from time to time be laid down in the income tax act 1961 or any other act covering taxation of income as will ensure or make the trust hereby established and income as eligible for exemption from taxation under the income tax act 1961 or any replacement or re-enactment ~~there of modification there of~~ under any other act governing taxation for the time being in India.

(ii) **BANK ACCOUNT:**

To open account with any Bank or post office in the name of the Trust and/or in the name of the said educational institutions or other establishments and/or otherwise as may be decided by the Managing trustee from time to time as the Managing trustee may think necessary. Any trustee/trustees, as authorized by the Managing trustee in its meeting, jointly or singly will be competent to exercise the powers contained in this clause.

(iii) The Trustees may out of the corpus of the subject matter of the trust spend such sale/proceeds or any part there of and appropriate such money or part there of for laying out, erecting and furnishing and building of Educational institution, libraries, ~~research institute or for incurring~~ any capital expenditure as may be unanimously resolved upon by the trustees or as may be allowed by court in capital expenditure i.e. on land, construction of building, expansion and procurement major equipments etc. for the Educational institutions and/or other establishments.

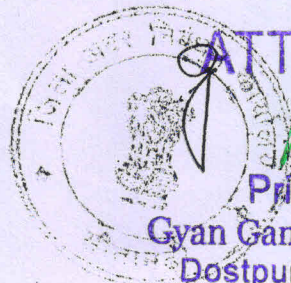

C. ROLE & RESPONSIBILITIES OF TRUST/TRUSTEES:

In furtherance of the (above) objects and other objects hereinafter contained in this deed the role & responsibilities of the Trust shall be as under:

- (i) To ensure that the school and maternity homes gets proper land, building, equipments, furniture and qualified staff at least as per the norms of the apex conferencing body .
- (ii) To ensure that the school and the maternity home is run as a community service and not as a business and that commercialization does not take place in the school maternity home in any shape whatsoever.
- (iii) To safeguard the autonomy of the principal and provide him total support except when the Principal goes against the established and clear directives laid down by the management.
- (iv) To have control over the School Management Committee and shall approve the budget/tuition fees and annual charges etc. for the school.
- (v) To have control over any capital expenditure.
- (vi) To generate funds for the needs of the school whether it is recurring or non-recurring.
- (vii) To generate funds for the needs of the school has the basic essential facilities such as laboratory Equipments, games and sports articles and other co-curricular activities Library Books etc.
- (viii) To ensure that the school is running as per the provisions of the education act/affiliation norms and is providing quality education to the children and for this to take necessary steps as per its need.
- (ix) To ensure that the maternity home is run as per the guide lines of the State health Deptt.

05. DONATIONS & CONTRIBUTIONS:

That the trust Fund may be augmented by the income from the initial fund and also by donations and other contributions.

07. ACCOUNTS AND AUDIT:

That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust. Annual accounts of the Trust shall be audited by a Chartered Accountant.

08. POWERS OF TRUSTEES:

That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- (I) Managing trustee has full right to increase or decrease the number of trustee maximum 15 and minimum of 3 through voting right.
- (II) The Trustees will advise and support the managing trustee to carry on day to day affairs of the trust.
- (III) To advise and manage the affairs of the trust as assigned by the Managing trustee appointed the settlor for a period specially mentioned or authorize declared null and void by a resolution taken by the Board of trustee. If Managing trustee resign or medically unfit to carry out the duties then all the trust members (founder & new members) will elect the managing trustees with consent of settler.
- (IV) To fill the casual vacancy on post of Managing Trustee becoming vacant, by electing another founder trustee and he shall hold the post of Managing trustee up to the conclusion of the next Annual General Meeting.
- (V) To constitute different committees like selection committee/departmental promotion committees for various categories of staff.
- (VI) To lay down conditions of service as per norms of NCTE/CBSE/Govt. and to approve promotion/appointment/termination of the employees as well as to grant special increments or rewards to staff.
- (VII) To accept any donation, contribution, grant or subscription in cash or in kind, from any person (s), body of persons or trust, with or without conditions.

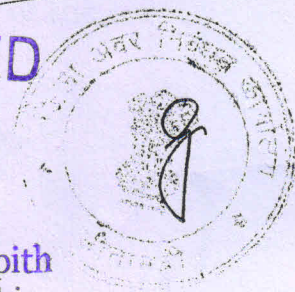

- (VIII) To apply the whole or any part of the income of the trust, or the trust fund or accumulations there to any one or more of the objects of the trust as the trustees may in their discretion, deem fit from time to time.
- (IX) To convert and deal with the trust property and/or any investments for the time being.
- (X) To invest the Trust Fund in shares, stock or debentures or other securities and investments in deposits with or loans to any company, bank, firm or any other person and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.
- (XI) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- (XII) To let out, demise any property comprising in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (XIII) To open account in the name of the trust/Trustees and/or institution run/conducted by the Trust with a bank, to operate such account and to give instructions to the bank and to provide for opening and operation of such account by the trustees or by an agent appointed by the trustees or by an agent appointed by the Managing Trustees.
- (XIV) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceeding regarding the Trust fund.
- (XV) To appoint or make provision for the appointment of any person for the purpose of the administration of the trust in such manner and subjects to such rules and regulations as the Trustees to hold any fund or investment subjects to the provisions of this deed in such manner and subjects to such rules and regulations as the trustees may from time to time think fit.
- (XVI) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the managements of the affairs there of and/or running any institution in furtherance of the trust and otherwise for giving effect to the objects of the trust.
- (XVII) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscriptions or donations made by them.
- (XVIII) To set a part and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part there of for any of the objects of the trust.

- (v) To prepare and present annual accounts of the Trust and to ensure annual audit of the accounts of the trust.
- (vi) To prepare and present periodically to the Board of trustees a true and correct picture of the expenditure of the trust.
- (vii) To look after the day to day functioning of the trust and will exercise powers under the direction and guidance of the founder trustees.
- (viii) To co-ordinate and exercise general supervision over all the activities of the trust.
- (ix) To do all other functions related to and incidentally there of on behalf of the trust in terms of the broad guidelines of the board of trustees/founder trustees.
- (x) To execute the policy decisions of the Board of Trustees and founder trustees.
- (xi) To preside over all the meetings of Board of trustees, Founder Trustees and Annual General Meeting as ex-officio Chairman.
- (xii) To open and operate bank A/C to apply for loan and credit facilities, to close the A/C, to buy properties and securities.

10. LIABILITY OF TRUSTEES:

The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor any banker or other person with whom the trust properties or any securities may have been deposited or kept.

11. BINDING & RELAXATIONS:

The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or there duties relating there to, Provided that nothing herein contained shall prevent the payment in good faith of remuneration or reward to any other employee or servant of the trust or to any member of the trust or other person in return for any service actually rendered to the trust.

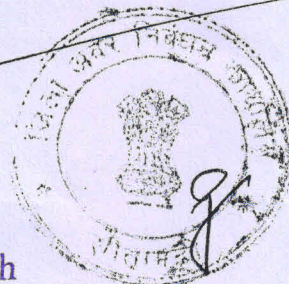

BOARD OF TRUSTEES: All the trustees by whatever name called shall constitute a Board of trustees.

The number of founder Trustess shall be 5. Those whose name and other details mentioned in the beginning the Trustees shall be hereinafter referred to as founder Trustees. Its remarkable that the founder Trustees can never be removed or terminated from the Trust. The founder Trustees shall constitute a Board of Trustees. Which shall comprise of member as many as the founder Trustees may feel suitable including the founder Trustees and other persons co-opted or nominated by one or any of the founder Trustees shall disqualify the persons or nomination or co-option.

The Board of Trustees shall choose from amongst themselves the office bearers of the Trust.

And Board decided there shall be following office bearers :-

- (a) Chairman Dileep Kumar
- (b) Vice Chairman Badri Baitha
- (c) Secretary Sudha Kumari
- (d) Treasurer Dipendra Kumar
- (e) Assistant Treasurer Rambabu Sharma

13. VACATION OF OFFICE OF THE TRUSTEES:

The Board of trustees for the time being will be at liberty to appoint additional Trustees for such period on such terms as to retirement and re-appointment as the trustees for the time being consider proper.

Any founder Trustee if he/she incapable of discharge in his duties, may at his own discretion nominate his/her legal heir, for the purpose to carry forward the responsibilities assigned to him by the Trust and the person nominated shall be come the founder Trustee.

Any casual vacancy in the founder trustees shall be filled up by the legal heir of the founder Trustee, by whom the seat is vacated. If any of the founder Trustees resign & refuse to remain associated with the Trust and in this case doesn't nominate any of his legal heirs the casual vancancy created in this manner shall be filled up by co-option by the remaining founder trustees. and this co-option shall be unanimous or with the written consent of all the remaining founder Trustees.

14. RULES AND REGULATIONS:

- (a) The founder trustees may from time to time frame rules and regulations for the trust, educational institutions nursing and maternity homes or other establishments, branches and/or divisions or other wise. In framing the rules and regulations by the founder trustees advice/recommendations of the trustees other than founder trustees shall be recorded and discussed by the founder trustees in its meeting.

- (b) The founder trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:-
 - (i) Two- Third number of trustees rounded to higher number subject to minimum three shall form a quorum for a meeting of the trustees.
 - (ii) Resolution passed without any meeting of the trustees but by circulation there of and evidenced in writing under the hands of four-fifth trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.

15. **ACCOUNTING YEAR:**

The accounting year of the trust shall be irrevocable for all times.

16. **IRREVOCABILITY:**

The trust and the trust funds shall be irrevocable for all times.

17. **APPLICATION OF INCOME TAX AT:**

All clauses herein are intended to secure exemption from Income Tax in the income of contributions and donations to the Trust and any clause or portion of this deed of Trust which is inconsistency with or repugnant to the sections of the Income Tax act 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the section to which the clause or part of a clause is repugnant or inconsistent comes into touch.

18. **AMALGAMATION-**

The Trustees may amalgamate the Trust with an other charitable Trust or institution having similar objective with prior permission on the charity-Commissioner/court /any other law as may be applicable for the time being if required and the Trust can also take over the another charitable Trust or Institutions having similar objectives.

19. **WINDING UP:**

In the event of dissolution or winding up off the Trust, the assets remaining as on the date of dissolution shall under know circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/organization whose objectives are similar to those of the Trust with the permission of the charity Commissioner/court /any other law as may be applicable for time being.

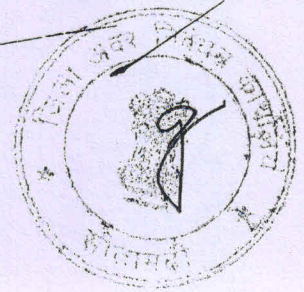
